# 2024 VET Flexible Industry Pathways Subsidised Courses

#### **EXPRESSING AN INTEREST IN A VET COURSE**

Thank you for expressing interest in undertaking a VET qualification in 2024.

Please read the information below carefully, which will outline the steps you will need to undertake to formalise your enrolment in this course. Note this information is only relevant to eligible students who meet the following criteria:

- 1. Access a VET course on the Governmentsubsidised training list.
- 2. Will be in year 11 OR year 12 in 2024.
- 3. Turns 16 years of age (or older) in 2024.
- 4. Have undertaken a relevant industry immersion activity such as:
  - a. Work experience
  - b. VET skills/try a trade
  - c. extensive career research

Evidence of this must be submitted with your application for the course.

## **APPLICATION PROCESS**

Students must first complete the expression of interest form. Upon completing the EOI form, the VET commitment to pay and training provider forms will be available for the chosen course from the student hub.

For the courses that are part of the **Adelaide Hills Student Pathways, you may proceed to complete** the 2024 Application Form. Please go to the AHSP website to complete (<u>https://www.ahsps.com.au/applicationdocuments</u>)

You must supply evidence of your industry immersion activity with a copy of your AHSP application. Please refer to dot point 4.

For students undertaking a subsidised VET course outside the Adelaide Hills Student Pathways network (such as AIE, The French Beauty Academy, Clip Joint, and Queensford College), you must go to the relevant training providers' websites and complete their digital application form. In this enrolment process, please use the following email address:

<u>dl.0783.vet@schools.sa.edu.au</u>. This will allow us to be informed of your application. You must supply evidence of your 'industry Immersion activity' to the student hub for your application to proceed to the next stage, VETRO referral.

All documents, including industry immersion evidence, must be completed in full and submitted to The student hub.



# INTERVIEWS

Students should be aware that some training providers and courses will require students to undertake an interview as part of the application process. Students will be notified of this directly but should be prepared by updating their resumes, finding their past school reports and work experience feedback, etc.

#### **VETRO REFERRAL**

Upon receipt of a student's completed application, Mount Barker High School will submit an online application (VETRO) to access State Government funding for a subsidised course on a student's behalf. Students and parents will receive an email notification when this occurs, and as part of the process, you will be required to respond to these emails permitting this application to proceed.

#### UAN ASSESSMENT

Once permission has been granted, students will be invited by the training company to attend an **Upfront Assessment of Need (UAN).** This will occur in term 4 and will be completed online or face-to-face. The UAN consists of a basic literacy and numeracy assessment to gauge what support students may need with their learning as part of the course. If a student drops below the entry standard for the course, they will be required to sit an additional, longer assessment to gauge what support is needed.

# VET COSTS

The following generic costs apply to undertake a Flexible Industry Pathways VET course. The VET Commitment to Pay must be received to finalise ALL vet applications:

- Administration fee \$150.00 (invoiced in term 1, 2024).
  - \* School card recipients pay only \$100.00.
- Course fee (invoiced in term 1, 2024).
  \* School card recipients are fully subsidised.
- Consumable fee (invoiced in term 1, 2024):
  \* School card recipients are fully subsidised.

# VET WITHDRAWAL

If a student withdraws from a VET course after it has begun, parents will be liable for the full amount of the course as charged by the training company. Additionally, students will miss out on SACE credits they would have gained. This will impact their SACE pattern and require them to study additional subjects.
